2020-21 SEASON COVID-19 NOTICE AND WAIVER

On behalf of my minor child, myself, and my household members, I hereby give permission for my child to attend the MYSO rehearsals and other related MYSO activities at the Milwaukee Youth Arts Center (MYAC), and I acknowledge that my child's participation in this program is wholly voluntary.

I and my child have read, and agree to adhere to, the following guidelines to help protect my child, other students, and MYSO and MYAC staff.

We agree to follow Center of Disease Control (CDC) and local health department guidelines and MYSO and MYAC policies and procedures for social distancing to reduce the spread of COVID-19. These policies and procedures include:

- All individuals will remain at least 6' apart at all times.
- Rehearsal start and end times will be staggered, to ensure appropriate physical distancing may be maintained when entering or exiting the building at all times. **Parents or other caregivers and siblings of students will not be allowed in the building during rehearsal time.**
- **Students and staff will have their temperature taken upon arrival each day, using a non- contact thermometer.** If a student or staff member shows a temperature of 100 degrees or higher, he/she will not be admitted into the building.
- Students and staff will be required to wear face coverings at all times as they enter and while at MYAC.
- The Commons area is closed, and students will move straight to their rehearsal hall with coats, cases,

and instruments to unpack for rehearsal. Students' personal materials will be kept with them at their chair in the rehearsal hall or studio, ensuring students maintain social distancing while placing and gathering their belongings.

- **Food will not be permitted in rehearsal halls or studios.** Water bottles will be permitted, and we encourage students to fill water bottles before arriving at MYAC. Water fountains are closed at MYAC.
- Rehearsals will be held in our rehearsal halls and studios, with chairs and stands 6' to 9' apart to ensure students and staff maintain at least six feet of separation at all times.
- All students will have a separate stand to ensure 6 feet of separation.
- In rehearsals, woodwind and brass players will wear face coverings during rest and instruction and will receive guidance on playing with devices to further enhance mitigation. The use of pads to collect condensation water will be required for all brass players
- **Rehearsal halls and classrooms will be cleaned and disinfected in between rehearsal sessions and nightly.**
- **Restrooms are open, however certain sinks and stalls are closed to ensure physical distancing.**
- Students will be expected to wash or sanitize their hands after using the restroom, sneezing, and/or coughing.
- **If a student falls ill while in class, he/she will immediately be excused from rehearsal or other related MYSO activities and placed in a marked Quarantine Zone.** A staff member with appropriate PPE will contact the student's guardian or emergency contact to pick up their student.
- **If the quarantined student shows symptoms of COVID-19 or has been ordered to test for COVID-19, the remainder of the rehearsal will be cancelled for that day, and MYSO staff in potential or actual contact with the affected student will work from home while quarantining for 10-14 days or until a negative COVID-19 test result is received. Students in the same group will be highly recommended to quarantine as well. In this case, the entire Milwaukee Youth Arts Center may shut down for 24 hours for disinfecting, and all programming will move to a virtual platform for that time period.**
- All performances will be shared with family and friends through a virtual platform.
- **In the event that we do not feel it is safe to carry out in-person classes, these sessions will be moved to a virtual platform.**

At this time, the legal environment for liability relative to the COVID-19 virus and its impact remains highly uncertain. As a result, it is critical that each student's guardian assess any risk for their child's health and safety in making the decision to attend MYSO's rehearsals or other MYSO related activities in the 2020-21 season. I acknowledge and agree on behalf of my child and me that we shall:

- i. abide by MYSO's COVID-19 related obligations and protocols;
- ii. recognize that these conditions are subject to change at any time;
- iii. accept all risk that my child may acquire COVID-19, and that COVID-19 may subsequently be transmitted from my child to me, my family, and members of my household.

I certify that my child is in good health, has no fever, and has no current issues that make it unsafe for my child to participate in the rehearsals, or other related MYSO activities which may not have a medical professional on staff. I agree to notify MYSO and will not send my child to rehearsals or other related MYSO activities if he/she, or any member of my household, develop a fever or illness, or test positive for COVID-19. I acknowledge that my child and I are responsible for ensuring that they take any necessary medications, and for avoiding any allergies.

I agree to fully indemnify MYSO and the Milwaukee Youth Arts Center against any claims by or on behalf of my child or me, including claims that MYSO and the Milwaukee Youth Arts Center were negligent and including but not limited to contracting an infectious disease such as COVID-19, and all property loss or damage including all fees and expenses that MYSO or MYAC may incur to defend such claims.

I hereby acknowledge that I have read, understand, and agree to the terms described above.
